



**Contract for services. By entering into this agreement with WebRecon LLC, customer acknowledges review and understanding of the following:**

Access to the WebRecon LLC's service is subject to approval by and provided under the sole discretion of WebRecon LLC, and may be revoked at any time for failure to comply with the terms of this document.

All information provided by WebRecon LLC is licensed only for use by the individual or entity that has purchased it (the "Purchaser"). Data is not to be shared, sold, or disseminated by the Purchaser in any fashion, written or otherwise, without advance, written permission from WebRecon LLC. Only individuals authorized by WebRecon LLC may access and use the website.

Payment is due upon invoicing. Account may be cancelled within first thirty days after setup with no invoice and no payment due. Service is offered on a month-to-month basis. All straight data purchases are final. Service cancellation requests are to be made in writing to WebRecon LLC, 6115 28<sup>th</sup> St SE, STE 105, Grand Rapids MI 49546, or by opening a support ticket on the web site. Service will be immediately terminated upon receipt.

After the free trial month, the base rate is billed at the beginning of each month for the month ahead. Usage charges incurred above the base rate will be billed on the next invoice for the previous month.

Arrangements may be made to automate payment by credit card if desired. At least thirty days notice will be given prior to any rate adjustments, after which customer may accept or cancel service without penalty. Monthly invoice will be based upon the following rate schedule, effective 8/27/2009:

\$249	Batch or monitor 250,000-499,999 accounts/month
\$299	Batch or monitor 500,000 + accounts/month
